

AN ORDINANCE AUTHORIZING THE CITY MANAGER OF THE CITY OF CAMERON, CLINTON AND DeKALB COUNTIES, MISSOURI TO ENTER INTO AN AGREEMENT FOR SERVICES WITH MANION COMPLETE CONCRETE LLC, FOR REPAIR OF SIDEWALKS

WHEREAS, The City of Cameron did solicit bids for the repair of sidewalks and did receive one (1) bid; and

WHEREAS, Staff having reviewed the bid received and determining Manion Complete Concrete LLC has met all the requirements and was the lowest and best bid with a base bid of \$7.50 per square foot, does hereby recommend approval of the Agreement for Services with Manion Complete Concrete LLC.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMERON, CLINTON AND DeKALB COUNTIES, MISSOURI AS FOLLOWS:

Section 1. The City Manager is hereby authorized to enter into a contract with Manion Complete Concrete LLC, for the 2012-2013 Sidewalk Repair Program all as per the agreement attached hereto and made a part hereof.

Section 2. The City Manager is authorized to execute any ancillary documents associated with this project.

Section 3. The Mayor is hereby authorized to sign this Ordinance on behalf of the City of Cameron.

Section 4. The City Clerk is hereby directed to attest to the Mayor’s signature.

Section 5. This Ordinance shall be in full force and effect from and after its passage.

AGREEMENT FOR SERVICES

THIS AGREEMENT, made on the 17th day of September 2012 by and between the CITY OF CAMERON, Clinton and DeKalb Counties, Missouri, a municipal corporation, hereinafter called "City", and MANION COMPLETE CONCRETE LLC, hereinafter called "Contractor".

WHEREAS, the City wishes to retain Contractor to furnish construction services for sidewalk repair authorized under the following sections:

Section 1. The Contractor will abide by the terms and conditions of the "Bid Proposal and Contract" regarding his scope of services and pricing as attached.

Section 2. The Contractor will abide by Missouri Division of Labor Standards attached heretofore.

Section 3. If the Contractor fails to perform the work in accordance with contract documents, the City retains the right of immediate termination, and right of reimbursement for any unearned funds.
