

AN ORDINANCE FOR THE CITY OF CAMERON, CLINTON AND DeKALB COUNTIES, MISSOURI REPEALING THE CURRENT WATER RATES AND ESTABLISHING NEW WATER RATES FOR CONSUMERS OF THE CAMERON MUNICIPAL UTILITIES

WHEREAS, the City of Cameron owns and operates a water supply, treatment and distribution system as a stand-alone non-profit municipal enterprise to serve the citizens of Cameron, and

WHEREAS, the system must maintain sustainability of operations, which includes meeting increasing for flow and/or quality; and

WHEREAS, the revenue received by the City must be sufficient to treat and deliver water to customers.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMERON, CLINTON AND DeKALB COUNTIES, MISSOURI AS FOLLOWS:

Section 1. Repeal the existing subsection (c) of Sec. 12-136, Water Rates, and replace it with a new subsection (c), setting new water rates.

(c) User charges shall be as follows:

Water Rates Effective 01-01-2014

Residential and Commercial

1 st 200 cubic feet.....	\$9.55
Next 1400.....	\$4.58 per 100 cu. ft.
Next 2000.....	\$3.15 per 100 cu. ft.
Excess.....	\$2.33 per 100 cu. ft.

Outside City Limits

1 st 200 cubic feet.....	\$19.10
Next 1400.....	\$9.16 per 100 cu. ft.
Next 2000.....	\$6.30 per 100 cu. ft.

Excess.....\$4.66 per 100 cu. ft.
Minimum Bill..... \$19.10

Multiple Dwelling Water

Minimum water charge is \$8.68 times the number of units in building.

Clinton County Public Water Supply District #3 (PWSD #3) and WMCC Rate

1st 1600.....\$4.62 per 100 cu. ft.

Next 2000.....\$3.19 per 100 cu. ft.

Excess.....\$2.39 per 100 cu. ft.

Public Water Supply District #3 (PWSD #3) Resale rate to Public Water Supply District #2 of Caldwell County (PWSD #2).

\$3.70 per 1,000 gallons

Minimum Charge is \$370.00 per month

Section 2. This ordinance hereby repeals all other ordinances pertaining to all water rates heretofore established for users of water in the City of Cameron, Missouri, and any and all other ordinances inconsistent herewith. This ordinance shall take effect and be in full force January 1, 2014.

Section 4. The Mayor is authorized to sign this ordinance approving it on behalf of the City.

Section 5. The City Clerk is hereby directed to attest to the Mayor's signature.
