

AN ORDINANCE AMENDING ORDINANCE 5827 FOR THE CITY OF CAMERON, CLINTON AND DeKALB COUNTIES, MISSOURI, THAT REPEALED AND ENACTED A NEW SECTION 6-115 OF ARTICLE V, ALCOHOLIC BEVERAGES OF CHAPTER 6, LICENSES AND BUSINESS REGULATIONS OF THE CAMERON CITY CODE, WITH RESPECT TO PUBLIC CONSUMPTION OF MALT LIQUOR (BEER) AND/OR WINE WITHIN THE CITY OF CAMERON, MISSOURI (*Fly-In/Concert*)

WHEREAS, the Annual Cameron Air Show will be held at the Cameron Memorial Airport on Friday June 6 through Sunday June 8, 2014; and

WHEREAS, the Cameron Air Show Organization has asked that the City Council allow the V.I.P. occupants and their associates the ability to drink malt liquor (beer) and/or wine in the V.I.P. designated area with no sale of malt liquor and/or wine occurring; and

WHEREAS, the Cameron Air Show Organization asked that the City Council limit the public consumption of alcoholic beverages to a specific time period and a well defined area during the Air Show event.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Cameron, Clinton and DeKalb Counties, Missouri, as follows:

Section 1. Recently enacted Section 6-115. Ordinance 5827, of Article V, Alcoholic Beverages, of Chapter 6, Licenses and Business Regulations of the City of Cameron Code is hereby amended.

Section 2. The amendment to Section 6-115 shall be enacted to include the following:

Sec. 6-115. Drinking in public allowed.

During the Annual Air Show Event from 3 p.m. Friday, June 6, 2014 to 4:30 p.m. Sunday, June 8, 2014 malt liquor (beer) and/or wine, as defined by Section 6-111, may be consumed at the following public locations, where consumption shall not constitute a violation of Section 6-114, Drinking in Public.

Locations: A designated area on the airport property designated as the V.I.P. area. Area as described in Exhibit One.

Section 3. The Mayor is authorized to sign this Ordinance.

Section 4. The City Clerk is directed to attest to the Mayor's signature.

Section 5. This Ordinance shall be in full force and effect from and after the date of its passage and approval.
