

**AN ORDINANCE DECLARING THE RESULTS OF THE  
GENERAL ELECTION HELD ON 7 APRIL 2015,  
FOR COUNCILMEMBERS, IN THE CITY OF CAMERON,  
CLINTON AND DeKALB COUNTIES, MISSOURI**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMERON,  
CLINTON AND DeKALB COUNTIES, MISSOURI, AS FOLLOWS:**

Section 1. Upon a certification of the returns, according to law, of the results of the Municipal General Election, held in the City of Cameron, Clinton and DeKalb Counties, Missouri, on 7 April 2015, for Councilmembers, the Council finds that same was held in all respects in conformity with the ordinance of the City of Cameron, Missouri, and laws of the State of Missouri; that the various Judges and Clerks were qualified and duly sworn in before entering upon the discharge of their respective duties; that the returns of said election were duly certified according to law; that from the certification of said election returns, the Council finds the following candidate received the following number of votes, said total covering the entire City of Cameron, Missouri:

Section 2. The Council further finds that the total number of votes cast by the entire City of Cameron, Missouri in the above election was 830.

Section 3. The Council further finds, after certification of said returns, that Darlene Breckenridge and Ronnie Jack were elected to three-year terms ending in April 2018.

Section 5. The Council, therefore, directs that Darlene Breckenridge and Ronnie Jack be commissioned as provided by law upon their qualifying according to law.
