**2009** - Case files from 2009 were evaluated for retention, destruction, and removal to long-term storage for the first time with the 2015 Records Destruction Resolution. Records are retained and moved to long-term storage for the following reasons: (F) class A felonies require permanent retention (POL 001); (J) sex crimes with a juvenile victim must be retained for 30 years after the victim reach 18 years of age (POL 001); (E) case files for which the Police Department still has evidence held; (M) case files which currently have an active MULES entry (ex: Stolen Gun); and (H) case files with historical significance. Most other case files must only be retained until disposition of the criminal court case, up to three years for other felonies if no charges are filed, or up to seven years for a felony traffic accident. **All 2009 case files will be destroyed except the case files listed below.
