

**A RESOLUTION FOR THE CITY OF CAMERON, CLINTON AND DEKALB COUNTIES, MISSOURI AUTHORIZING THE CITY MANAGER TO EXECUTE ON BEHALF OF THE CITY A PETITION FOR VOLUNTARY ANNEXATION TO THE CITY OF CAMERON, CLINTON AND DEKALB COUNTIES, MISSOURI**

**WHEREAS**, the City owns certain real property that is located outside of the corporate limits of the City; and

**WHEREAS**, the certain real property is continuous and compact to the current corporate limits of the City; and

**WHEREAS**, the City desires that the certain real property be voluntarily annexed into the corporate city limits pursuant to the voluntary annexation procedure laid out in Section 71.012 of the Revised Statutes of Missouri.

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CAMERON, CLINTON AND DEKALB COUNTIES, MISSOURI, AS FOLLOWS:**

**THAT** the City Council hereby authorizes the City Manager to execute on behalf of the City a Petition for Voluntary Annexation to the City of Cameron, Clinton and DeKalb Counties, Missouri, with respect to the following real property:

**Clinton County:**

Tract 1:

The North Half (N ½) of the Southeast Quarter (SE ¼) and the East 10 acres of the North Half (N ½) of the Southwest Quarter (SW ¼) of Section Twenty-five (25), Township Fifty-seven (57) North, of Range Thirty (30) West, all in Clinton County, Missouri.

Tract 2:

The East Half (E ½) of the Northeast Quarter (NE ¼) of Section Twenty-five (25), Township Fifty-seven (57) North, of Range Thirty (30) West, Clinton County, Missouri.

**Caldwell County:**

The Northwest Quarter (NW ¼) of Section 30, Township 57 North, Range 29 West of the Fifth Principal Meridian, Caldwell County, Missouri, excepting that part heretofore acquired by the State of Missouri for highway purposes. EXCEPTING therefrom a one acre tract described as commencing on the East right-of-way line of Caldwell County Route BB at a point 8.37 chains South of the North line of the Southwest Quarter (SW ¼) of the Northwest Quarter (NW ¼) of Section Thirty (30), Township Fifty-seven (57), of Range Twenty-nine (29), thence East 3.17 chains, thence South 3.17 chains, thence West 3.17 chains, thence North 3.17 chains to the point of beginning.

The Northwest Quarter (NW ¼) of the Northeast Quarter (NE ¼) of Section Thirty (30), Township Fifty-seven (57), Range Twenty-nine (29), Caldwell County, Missouri.

**DeKalb County:**

Tract 1:

All of the West 220 feet of a tract described as: All of the Southeast Quarter of the Southwest Quarter of Section Ten (10), Township fifty-seven (57), of Range Thirty (30), except the South One Thousand (1,000) feet, DeKalb County, Missouri, subject to that part, if any, in streets, roadways, highways or other public rights-of-way.

Tract 2:

All of the Southeast Quarter of the Southwest Quarter EXCEPT the South 1,000 feet, and EXCEPT the West 220 feet thereof, AND all of the West 405 feet of the Southwest Quarter of the Southeast Quarter, EXCEPT the South 1,000 feet thereof, all in Section Ten (10), Township fifty-seven (57), Range Thirty (30), DeKalb County, Missouri, subject to that part, if any, in streets, roadways, highways or other public rights-of way, **and**

**FURTHER THAT** the Mayor, the City Manager, the City Attorney and other appropriate City officials are hereby authorized to take any and all actions as may be deemed necessary or convenient to carry out and comply with the intent of this Resolution and to execute and deliver for and on behalf of the City all certificates, instruments, agreements and other documents, as may be necessary or convenient to perform all matters herein authorized.
