

A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF CAMERON, CLINTON, DeKALB AND CALDWELL COUNTIES, MISSOURI TO EXECUTE A QUIT CLAIM DEED IN FAVOR OF JOHNNY AND DONNA FEIGHERT

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CAMERON, CLINTON, DeKALB AND CALDWELL COUNTIES, MISSOURI AS FOLLOWS:

QUIT CLAIM DEED

THIS DEED, made this _____ day of _____, 2018, between the City of Cameron, Missouri, a Missouri municipal corporation, 205 North Main Street, Cameron, Missouri 64429, Grantor, and Johnny R. and Donna B. Feighert, Husband and Wife, Grantee.

WITNESSETH: In consideration of the payment of the sum of TEN DOLLARS AND OTHER VALUABLE CONSIDERATION (\$10.00 & O.V.C.), the receipt of which is hereby acknowledged, Grantors do hereby REMISE, RELEASE, AND FOREVER QUITCLAIM to Grantee, any right, title or interest the Grantor may have in a tract of land, lying situated and being in the County of Clinton, State of Missouri, to wit:

Tract 1

Commencing at the Southeast Corner of Lot 141 of Missouri Land Association Outlots in the City of Cameron, Clinton County, Missouri; thence with the South line of said Lot 141, South 89 degrees 11 minutes 51 seconds West, 141.60 feet to the Point of Beginning; thence continuing along said line, South 89 degrees 11 minutes 51 seconds West, 5.87 feet; thence departing from said line, North 00 degrees 17 minutes 37 seconds East, 430.39 feet to the South line of a tract of land recorded in Book 2016 of Page 2239 in the Office of Register of Deeds for Clinton County; thence along said line, North 89 degrees 43 minute 42 seconds East, 0.50 feet; thence departing from said line, South 00 degrees 25 minutes 18 seconds East, 430.31 feet to the Point of Beginning.

Tract 2

Commencing at the Southeast Corner of Lot 141 of Missouri Land Association Outlots in the City of Cameron, Clinton County, Missouri; thence with the South line of said Lot 141, South 89 degrees 11 minutes 51 seconds West, 147.48 feet to the Point of Beginning; thence continuing along said line, South 89 degrees 11 minutes 51 seconds West, 20.17 feet to the West line of the East half of Lot 141; thence along the West line of the East half of Lots 140 and 141, North 00 degrees 27 minutes 11 seconds West, 430.55 feet to the South line of a tract of land recorded in Book 2016 at Page 2239 in the Office of Register of Deeds for Clinton County; thence along said line, North 89 degrees 43 minutes 42 seconds East, 25.77 feet; thence departing from said line, South 00 degrees 17 minutes 37 seconds West, 430.39 feet to the point of beginning.

TO HAVE AND TO HOLD THE SAME, with all and singular rights, immunities, privileges and appurtenances thereunto belonging, unto Grantee, its successors and assigns forever, so that neither Grantor nor their heirs, nor any other person or persons, for them or in their name or behalf, shall or will hereafter claim or demand any right or title to the aforementioned premises or any part thereof, but they and each of them shall, by these presents, be excluded and forever barred.
