

**AN ORDINANCE FOR THE CITY OF CAMERON, MISSOURI REPEALING THE CURRENT WATER RATES AND ESTABLISHING NEW WATER RATES FOR CONSUMERS OF THE CAMERON MUNICIPAL UTILITIES**

**WHEREAS**, the City of Cameron owns and operates a water supply, treatment and distribution system as a stand-alone non-profit municipal enterprise to serve the citizens of Cameron, and

**WHEREAS**, the system must maintain sustainability of operations, which includes meeting increasing needs for flow and/or quality; and

**WHEREAS**, the revenue received by the City must be sufficient to treat and deliver water to our customers.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMERON, MISSOURI AS FOLLOWS:**

Section 1. Repeal the existing subsection (c) of Sec. 12-136, Water Rates, of Division 5, Rates and Charges, of Article II, Water, of Chapter 12, Water, Sewage and Electricity of the City of Cameron Code and replace it with a new subsection (c), setting new water rates as follows:

(c) User charges shall be as follows:

Water Rates Effective 10-01-2019

*Residential and Commercial*

First 1500 gallons.....	\$14.52
Next 10,500.....	\$9.28 per 1000 gallons
Next 15,000.....	\$6.38 per 1000 gallons
Excess.....	\$4.74 per 1000 gallons

*Outside City Limits*

First 1500 gallons.....	\$29.04
Next 10,500.....	\$18.56 per 1000 gallons
Next 15,000.....	\$12.76 per 1000 gallons
Excess.....	\$9.48 per 1000 gallons

Minimum Bill.....\$29.04

*Multiple Dwelling Water*

Minimum water charge is \$14.52 times the number of units in building.

*Clinton County Public Water Supply District #3 (PWSD #3) and WMCC Rate*

First 12,000 gallons.....\$9.34 per 1000 gallons

Next 15,000.....\$6.50 per 1000 gallons

Excess..... \$4.85 per 1000 gallons

*Public Water Supply District #3 (PWSD #3) Resale rate to Public Water Supply District #2 of Caldwell County (PWSD #2).*

Per 1,000 gallons.....\$5.62

Minimum Charge is \$562.00 per month

Section 2. This ordinance hereby repeals all other ordinances pertaining to all water rates heretofore established for users of water in the City of Cameron, Missouri, and any and all other ordinances inconsistent herewith. This ordinance shall take effect and be in full force October 1, 2019.

Section 4. The Mayor is authorized to sign this ordinance approving it on behalf of the City of Cameron.

Section 5. The City Clerk is hereby directed to attest to the Mayor's signature.

Passed and approved on third and final reading this 3<sup>rd</sup> day of September 2019.
