It is understood that Kent Osborn will meet the following requirements:

- Acknowledge this permit is for a one time event.
- Keep fire suppression equipment near the fire.
- No burning within 25 feet of any structure.
- All burn material must be DNR approved (yard waste only).
- This permit is revoked if "The National Weather Service" sustained or forecast wind for the area is above 12 MPH and or wind gusts are greater than 15 MPH.
- No burning in City right-of-ways or utility easements.
- All other rules and regulations of the City of Cameron code apply.
