Terms: St. Munchin Church is permitted to have a ceremonial fire in a "fire pit" on Saturday, April 23, 2011 from 7: PM through 10: PM. The "fire pit will be located in front of the church on private property.

It is understood that St. Munchin Church will meet the following requirements:

- Acknowledge this permit is for a one time event.
- Keep fire suppression equipment near the fire.
- Burn only between the hours of **7:00 PM** and **10:00 PM**.
- No burning within 25 feet of any structure.
- All burn material must be DNR approved (yard waste only).
- This permit is revoked if "The National Weather Service" sustained or forecast wind for the area is above 12 MPH and or wind gusts are greater than 15 MPH.
- No burning in City right-of-ways or utility easements.
- All other rules and regulations of the City of Cameron code apply.

A copy of this permit will be delivered to the Cameron Public Safety Facility-Cameron Police Department and Cameron Fire Department.
