- (a) *Each new application for a license required by this article shall be submitted to the Chief of Police, the Fire Chief, the Building Inspector and if applicable the Special Events Committee, who, through their duly authorized agents or employees or through such other departments or persons who may from time to time be designated by the Council, shall make an immediate investigation of the statements contained in the petition and of the safety of the premises, sanitary conditions of the premises, impact on existing businesses in the area, and impact on the youth and citizens in general of the community and a verbal report of the finding of such investigations shall be made to the Council.*
- (b) *After a new application has been made and a license issued under this division, the council may, at any reasonable time, request a new investigation of the licensee or of the premises or both, and the results of such subsequent investigation shall be reported to the Council. (§ Sec. 6-145)*
